2. The work involves SITC of 400 KVA compact type Sub-station
3. The criteria and terms & conditions for the specialized firms and registered contractors of above departments in r/o the works shall be under:-
The specialized firms and approved contractors should produce definite proof along with application from the appropriate authority of having satisfactorily completed similar works during the last 07 years ending December – 2011 as specified below
Two Similar works each of value not less than 60% of the estimated cost put to tender or one similar work each of value not less than 80% of the estimated cost put to tender in Central/State Government/ Government under taking/Autonomous body.
Similar works mean:- "SITC of Sub-Station comprising of transformers, HT/LT Panel & Cables etc".
- 4 Attested copies of completion certificate issued by the officer of the client department of the rank of Executive Engineer or equivalent officer will have to be furnished along with the application. The completion certificate must clearly indicate.
 - i) Name of work
 - ii) Value of work.
 - iii) The date of completion of work.
 - iv) Performance of the work.

The firms who wish to tender for the work may submit their application by 3:00 P.M on 10.2.2012 the same shall be opened at 3:30 P.M on the same day in the office of Executive Engineer (E)-Chandigarh,CCW AIR, Sector-42A,Chandigarh in the presence of representatives of the firms who would like to be present.
6. The department reserves the right to reject or accept any application without assigning any reason.
7. The firm should be registered with sales tax authority (Work contract cell) and submit the copy of the same
8. If any information furnished by the applicant is found incorrect at a later stage, such agency will liable to be debarred from tendering/taking up of work. The department reserves the right to verify the particulars furnished by the applicant independently.
9. The date of sale and opening of tender papers shall be intimated to the firms who fulfill the prescribed P.Q criteria and approved by the competent authority.
- 10 The firm will have to deposit Earnest Money at the time of submission of tender papers
- 11 No application shall be entertained after due date and time.
- 12 The value of executed works shall be brought to the current costing level by enhancing The actual value of work at simple rate of 7% p.a, calculated from the date of completion to the last date of receipt of application for pre-qualification.
