The Tender documents excluding standard form can be obtained from the office of Executive Engineer (C), CCW, AIR, Lucknow Division, Lucknow (UP) upto 16.00 hrs on all working days on payment of Rs. 1,000/- ( Rs. One thousand only ) in cash ( non- refundable) towards the cost of tender alongwith earnest money in Deposit at Call Receipt of a Scheduled Bank/fixed deposit receipt of a Scheduled bank/ demand draft of a scheduled bank issued in favour of Executive Engineer (C), Prasar Bharti, CCW, AIR, Lucknow (U.P.). A part of the earnest money is acceptable in the form of Bank guarantee also. In such case, 50% of the earnest money or Rs. 20 lakhs, whichever is less, will have to be deposited in shape prescribed above, and balance in shape of Bank Guarantee. The FDR shall be accepted only if it is valid for a period of Six months or more after the last date of receipt of the tender.

For the work of internal electrification, the applicants should either be enlisted itself in CPWD in appropriate class and category or will have to be associate with himself an eligible firm enlisted in CPWD in appropriate class and category . For this the tenderer will be required to submit the name of only one eligible CPWD Contractor for the work of internal electrical installation which he intends to associate for the job at the time of submission of tender. The tender forms will be issued to the eligible contractors having successfully completed three similar works each costing not less than Rs.50.00 lakhs

or two similar works each costing not less than Rs. 70.00 lakhs or one similar work costing not less than Rs. 100.00 lakhs during last 7 years ending last day of the month previous to the one in which the tenders are invited. For the purpose of this clause 'similar work' means **building work** only. The value of executed work shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to the last date of receipt of applications for tender.

Intending tenderers must produce original documents such as valid registration, sales tax /VAT registration certificate for works contract, experience certificate, Partnership deed etc., along-with attested true copies enclosed with the application before tender papers can be sold to them..

The department reserves the right to reject any prospective application without assigning any reason.
