The criteria, terms and conditions for the specialized firms (Non-Registered) in r/o above works shall be as under :-

1. Only those firms who have successfully completed during the last 7 years ending **Dec-2009**, two similar works of 60% or one work aggregating to 80% of estimated cost in Central / State Govt. / Govt. Undertaking / Autonomous body. The Agency shall submit the name of sub-letting contractor of I.E.I. work along with the application.
2. Completion Certificate issued by the officer of the client department not below the rank of Executive Engineer(E) or equivalent will have to furnished along with the application. The completion certificate must clearly indicate.
  - a) - The date of completion work
  - b) - Nature of Work
  - c) - That the Work has been completed satisfactorily
3. The contractor/firms should be registered with Sales tax authority (Work contract Cell) / and submit TIN certificate and latest quarterly return of tax submission issued by Delhi Sales Tax Department (Work Contract Cell). Please enclosed the attested copies for the same. Otherwise the application will be out rightly be rejected.
4. Application along with enclosures shall be submitted to AE(E), CCW:AIR, Doordarshan Bhawan, Tower "B" Mandi House, New Delhi in a sealed envelop which shall be subscribed "**PQ Application for respective Work**"
5. The firms who wish to tender for the work may submit their application by 3.00 p.m. on **2-3-2010**. The same shall be opened at 3.30 p.m. on the same day in the office of AE(E), CCW:AIR, Doordarshan Bhawan, Tower "B", Mandi House, New Delhi in the presence of representatives of the firms who would like to be present.
6. The department reserves the right to reject any application without assigning any reasons or to restrict the list of Pre-qualified contractors to any number deemed suitable by it, if too many applications are received satisfying the basic P.Q. criteria.
7. If any information furnished by the applicant is found incorrect at later stage, he will be liable to debar from tendering / taking up of work. the department reserves the right to verify the particulars furnished by the applicant independently.
8. The date of sale and opening of tender papers shall be intimated to the firms who fulfill the prescribed P.Q. criteria and are approved by the competent authority.
9. No application shall be entertained after due date and time.
