The criteria and terms and conditions in r/o above works for the specialized firms and registered contractors of above department shall be as under:-

1. The specialized firm and approved contractors should produce definite proof along with application from the appropriate authority of having satisfactorily completed similar works during the last 07 years ending **June-2011** as specified below:-

Three similar work of each of value not less than 40% of the estimated cost put to tender or two similar works of each of value not less than 60% of the estimated cost put to tender or One similar work of each value not less than 80% of estimated cost put to tender in central/state Government/Government under taking/Autonomous body.

The definition for similar work is as under:

**Operation and general maintenance of AC plant upto 100 TR and above.**

2. Attested copies of completion certificate issued by the officer of the Client Department not below the rank of Executive Engineer or equivalent will have to be furnished along with the application. The completion certificate must clearly indicate.
  - a. Date of completion of work.
  - b. Nature of work.
  - c. That the work has been completed satisfactorily.
  - d. Value of work executed.
3. The firms should be registered with Sales tax Authority (Work Contract Cell) and TIN issued by Sales Tax Department (work Contract Cell).
4. The firms should be registered with **ESI/EPFO** & submit their registration certificate along with application failing which their application shall be summarily rejected.
5. The firms who wish to tender for the work may submit their application by 3.00 P.M. on above date. The same shall be opened at 3.30 P.M. on the same day in the office of EE (E)-II, CCW, AIR, Pushpa Bhawan, New Delhi in the presence of representatives of the firms who would like to be present.
6. The department reserves the right to reject any or all application without assigning any reason.
7. If any information furnished by the applicant is found incorrect at a later stage, such agency will be liable to debar from tendering/taking up of work. The department reserves the right to verify the particulars furnished by the applicant independently.
8. The date of sale and opening of tender papers shall be intimated to the firms who fulfill the prescribed PQ criteria and are approved by the competent authority.
9. No application shall be entertained after due date and time.

10. The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% p.a, calculated from the date of completion to the last date of receipt of application for pre-qualification.
