The criteria and terms & conditions for the specialized firms (Non-Registered in respect of above works shall be as under:-

1. Only those firms who have successfully completed during the last 07 years ending 31/01/2010, Three similar works each of value not less than 40% of the Estimated cost put to tender, two similar works of 60% or one work aggregating to 80% of estimated cost in Central /State Govt./Govt. Undertaking/Autonomous body.
2. Attested copies of Completion certificate issued by the officer of the client department not below the rank of Assistant Engineer or equivalent will have to be furnished along with the application. The completion certificate must clearly indicate:-
 1. Name of Work
 2. Value of Work
 3. The date of completion work.
 4. Nature of Work.
 5. That the work has been completed satisfactorily
- 3 The firms should be register ed with Sales Tax Authority (Work Contract Cell) and must submit Tax Clearance Certificate (VATCC) issued by Sales Tax Authority (Work Contract Cell)
- 4 Application along with enclosures shall be submitted to Assistant Engineer(E), CCW, AIR, Sirifort Auditorium, New Delhi in a sealed envelop which shall be subscribed " PQ application for respective work".
- 5 The firms who wish to tender for the work may submit their application by 3.00PM on 26.02.2010. the same shall be opened at 3.30 PM on the same day office of Assistant Engineer(E), CCW, AIR, Sirifort Auditorium, New Delhi in the presence of representative of the firms who would like to be present.
- 6 The department reserves the right to reject any application without assigning any reasons or to restrict the list of pre-qualified contractors to any number deemed suitable by it, if too many applications are received satisfying the basic PQ criteria.
- 7 IF any information furnished by the applicant is found incorrect at later stage, he will be liable to debar from tendering / taking up of work. The department reserves the right to verify the particular furnished by the applicant independently.
- 8 The date of sale and opening of tender papers shall be intimated to the firms who fulfill prescribed PQ criteria and are approved by the Competent Authority.
- 9 The firms should be registered with Sales Tax Authority (Work Contract Cell) and must submit Tax clearance Certificate (VATCC) and TIN issued by with Sales Tax Authority (Work Contract Cell) for the period ending 12/2009.
- 10 No application shall be entertained after due date and time.
