The Assistant Engineer (E)-II, CCW, AIR, Room No. 1129, 11th Floor, Soochna Bhawan, New Delhi on behalf of President of India invites Pre-qualification applications from approved and eligible contactors of CPWD and those of the appropriate list of Department Telecommunications, (MTNL/BSNL), MES, Railways Delhi State PWD or specialized firms in the relevant field for the following work:-

Approved agencies should submit copies of approval and latest VAT/service Tax clearance certificate the Criteria and terms & conditions for specialized firm shall be as under:-

1. The firm (i.e. non approved contractors) should produce definite proof alongwith application from the appropriate authority, which shall be to the satisfaction of the competent authority, of having satisfactorily completed similar works during the last 07 years ending December 2009 as specified below:-
Two similar completed works of aggregate cost not less than the amount equal to 60%. Or one similar completed work of aggregate cost not less than the amount equal to 80% of estimates cost in central / state Government / Government under taking / Autonomous body.
2. Completion certificate issued by the officer of the client department not below the rank of Executive Engineer or equivalent will have to be furnished alongwith the application. The completion certificate must clearly indicate.
 - a. The date of completion work.
 - b. Nature of work.
 - c. That the work has been completed satisfactorily.
3. The firms should be registered with service Tax Authority and must submit latest Tax Clearance Certificate.
4. Application alongwith self attested enclosures shall be submitted to AE(E)-II, CCW, AIR, Soochna Bhawan, New Delhi in a sealed envelope which shall be subscribed "PQ application for the said work".
5. The firms who wish to tender for the work may submit their application by 3:00 PM 08.03.2010 the same shall be opened at 3:30 PM on the same day in the office of AE(E)-II, CCW, AIR, Soochna Bhawan, New Delhi in the presence of representatives of the firms who would like to be present.
6. The department reserves the right to reject any application without assigning any reasons or to restrict the list of Pre-qualified contactors to any number deemed suitable by it, if too many applications are received satisfying the basic P.Q. criteria.
7. If any information furnished by the applicant is found incorrect at later stage, such agency will be liable to debar from tendering / taking up of work. The department reserves the right to verify the particulars furnished by the applicant independently.
8. The date of sale and opening of tender papers shall be intimated to the firms who fulfill the prescribed P.Q. criteria and approve by the competent authority.
9. No application shall be entertained after due date and time.
