Item rate/percentage quotations are invited on behalf of the President of India from approved and eligible suppliers of this office for the materials, **Purchase of following spares for BEL FM Txr. for ,AIR ,Network**

i) 20Nos Absorber Resistance 50 Ohms/800Watt Part No.9186309.for MOSFET Power Amp

ii) 20Nos 50 Ohm 3 dB Attenuator Part No.4006102301855 for MOSFET Power Amp.

1. The material is estimated to cost Rupees-----Nil----- This estimate, however, is given merely as a rough guide.
2. The Quotationer/Tenderer must produce Income Tax clearance certificate in the revised form as per Ministry of Finance instructions issued from time to time failing which the quotation/tender will be treated as cancelled.
3. The time allowed for supplying the material will be one month from the date of written order to supply the material.
4. The Quotations should be remain open for acceptance for a period of 90 days from the date of opening, otherwise quote the validity period.
5. Quotation/Tender, which should always be placed in sealed envelope, with the name of material and due date written on the envelope will be received by the Station Engineer, Central Stores, All India Radio, 444A, Akashvani Bhavan, Parliament Street, New Delhi-110001.(By Registered Post) **up to 03:00 P.M on 26.11.2009** and will be opened by him or his authorized representative in his office on the same date at 03.30 P.M.
6. The competent authority on behalf of President of India does not bind himself to accept the lowest or any other tender, and reserves to himself the authority to reject any or all of the Quotation/Tender received without the assignment of a reason. All Quotation/Tenders in which any of the prescribed conditions are not fulfilled or are incomplete in any respect are liable to be rejected.
7. Canvassing whether directly or indirectly, in connection with Tender/Quotation is strictly prohibited and the Tender/Quotation submitted by the contractors/suppliers who resort to canvassing will be liable to rejection.

8. The competent authority on behalf of President of India reserve to himself the right of accepting the whole or any part of the Tender shall be bound to perform the same at the rate quoted.

9. The Quotation/ Tender shall be accompanied by earnest money, (unless exempted) of Rs. **Nil** in cash/ Demand Draft of a scheduled Bank issued in favour of Station Engineer, Central Stores (BCI) Prasar Bharati All India Radio New Delhi.

10. The Quotation/Tender for the materials shall remain open for acceptance for a period of 90 days from the date of opening of tender. If any Tenderer/Suppliers withdraws his Tender/Quotation before the said period or makes any modifications in the terms & conditions on the Tender/Quotation which are not acceptable to the department, then the government shall, without prejudice to any other right or remedy, be at liberty to forfeit 50% of the said earnest money as aforesaid.

11. Kindly send technical specification of the component.

12. In case of quotation of F.O.R. Station of dispatch basis, the purchaser will not pay separately transit insurance and the supplies will be responsible until the stores arrive in good conditions at the destination. Tender/Quotation in which transit insurance has been specified as an additional item of expenditure are liable to be ignored.

13. In case this is second enquiry your quotation in response to the first enquiry be presumed to be valid up to 120 days from the last date mentioned in para 5 above unless we hear from you. Delivery period and rate of S. Tax & Excise duty etc. if any may also please be quoted separately.
