6. The competent authority on behalf of President of India does not bind himself to accept the lowest or any other tender, and reserves to himself the authority to reject any or all of the Quotation/Tender received without the assignment of a reason. All Quotation/Tenders in which any of the prescribed conditions are not fulfilled or are incomplete in any respect are liable to be rejected..
7. Canvassing whether directly or indirectly, in connection with Tender/Quotation is strictly prohibited and the Tender/Quotation submitted by the contractors/suppliers who resort to canvassing will be liable to rejection.

8. The competent authority on behalf of President of India reserve to himself the right of accepting the whole or any part of the Tender shall be bound to perform the same at the rate quoted.

9. The Quotation/ Tender shall be accompanied by earnest money, (unless exempted) of Rs. Nil in cash/ Demand Draft of a scheduled Bank issued in favour of Station Engineer, Central Stores (BCI) Prasar Bharati All India Radio New Delhi.
10. The Quotation/Tender for the materials shall remain open for acceptance for a period of 90 days from the date of opening of tender. If any Tenderer/Suppliers withdraws his Tender/Quotation before the said period or makes any modifications in the terms & conditions on the Tender/Quotation which are not acceptable to the department, then the government shall, without prejudice to any other right or remedy, be at liberty to forfeit 50% of the said earnest money as aforesaid.
11. Kindly send technical specification of the component.
12. In case of quotation of F.O.R. Station of dispatch basis, the purchaser will not pay separately transit insurance and the supplies will be responsible until the stores arrive in good conditions at the destination. Tender/Quotation in which transit insurance has been specified as an additional item of expenditure are liable to be ignored.
13. In case this is second enquiry your quotation in response to the first enquiry be presumed to be valid up to 120 days from the last date mentioned in para 5 above unless we hear from you. Delivery period and rate of S. Tax & Excise duty etc. if any may also please be quoted separately.
