These will be opened on the same day at 3.30 P.M. in the presence of representatives of the firms who would like to be present.
4. If any information furnished by the applicant is found in-correct at a later stage, he will be liable to debar from tendering/ taking up work. The department reserves the right to verify the particulars furnished by the applicant independently.
5. The department reserves the right to reject any prospective application without assigning any reason and to restrict the list of approved contractors to any number deemed suitable by it , if too many applications are received satisfying the based eligibility Criteria.
6. No application shall be entertained after due date. The date of sale of tender and date of opening of tender papers shall be intimated to the firms who full fill the prescribed P.Q. criteria and approved by the competent authority.
